It is a matter of great pleasure for all of us to celebrate the 150th anniversary of the International Telecommunication Union by opening the Bangalore Chapter of ITU-APT Foundation of India, which incidentally is the location where it was registered eleven years ago as an autonomous not-for-profit scientific society comprising ICT professionals and industry to serve as a Think Tank for the development of ICT sector and undertake activities, among others, aimed at building national consensus on regional and global issues for deliberations at APT and ITU. As sector member of ITU-D and ITU-T and likely of ITU-R (in process), the Foundation plays a meaningful role, in submitting its proposals to them as relevant through the Ministry of IT and Communications, Government of India, in matters relating to the ICT policy and regulation, standardization and radio regulations. Far-sighted Government IT policy that in the early seventies recognized the potential of digital technology, created R&D and industry-friendly environment that fueled the growth of private sector IT industry, some of which rank today amongst the world's top companies. It is no wonder that whenever information technology is talked about in an international forum, Bangalore is inevitably mentioned. If anywhere the vision of our founding fathers, to give India the scientific temper, is realized, it is here in Bangalore that it has been truly achieved! 20th Century concluded with disruptive technology of Internet that brought about a paradigm shift in information and communication technologies, and that with social media and mobile communications has succeeded to a large extent in the empowerment of masses. Digital India is the program that is expected to usher in a new social and economic order to improve the quality of life by several orders of magnitude. Twenty-first century with ubiquitous communications, internet of things, robotics, AI, and so on, is unfolding other challenges, particularly cyber security, threatening peace and endangering human life. The Chapter at Bangalore would be best suited to provide a forum for addressing these and other emerging issues.

That the chapter at Bangalore starts its full-fledged activities coinciding with the 150th year celebrations of ITU is very auspicious and augurs well for its future. Commensurate with the ICT ecosystem of the metropolis, the spirit of goodwill and cooperation of IIIT-B, ISRO, CDAC, Amrita University, and other esteemed organizations, and the hard work put in by the Foundation's core members team at Bangalore, I am sure that the inaugural function will be a great success. I thank all the cooperating institutions and wish that I was there at Bangalore to savor and rejoice the inaugural event with distinguished guests, participants and fellow members, but I have to be content by sending my best

wishes from the Silicon Valley in California to its counterpart in India! For me personally, it is a dream come true!
